

## STATUTES

### „HARLEY-DAVIDSON CLUB EAST WAY z.s.“

#### art. I

##### **Name and registered office, scope and character of the association**

1. The name of the association is: " **HARLEY-DAVIDSON CLUB EAST WAY z.s.**" (hereinafter "association");
2. The seat of association is the address: Pod strání 387/12, 500 06 Hradec Králové;
3. The association operates throughout the Czech Republic, the association is not divided into organizational units – the association is locally relevant organizational unit;
4. Character of the association – the association is a registered association pursuant to Act No. 89/2012 Coll., the Civil Code.

#### art. II

##### **The purpose of the association**

The purpose of the association is to contribute to the promotion of single-track transport, road safety and the association of Harley-Davidson motorcycle owners and their supporters.

#### art. III

##### **Objectives of the association and the subject of its activities**

1. Organizing and organizing social events for owners and supporters of single-track vehicles;
2. Mapping of the most suitable road routes for single-track vehicles and dangerous sections;
3. Organizing and supporting moto-touristic events, support for sports, tourism and social activities;
4. Cooperation with other and international bodies with similar objectives or orientations (for the purpose of assistance, exchange of information, knowledge and experience), including possible participation in these bodies;
5. Implementation of educational activities;
6. Other forms of activities and specification of activities are determined by the membership meeting.

#### art. IV

##### **Membership in the association**

1. Natural persons over the age of 15 may be members of the association (the membership of a minor must be approved by his/her legal representative);
2. The membership base consists of members and honorary members;
3. The application for membership is accepted by the chairman. Membership is created by the registration of a member after prior approval of the application by the committee of the association – member becomes expectant for trial period of 12 months. After 12 months of trial and successful approval of the committee of the association, expectant becomes a regular member. The trial period of expectant can be shortened or extended by the committee;
4. By the expulsion of a member of the association or the voluntary departure of a member, no right to property settlement arises;
5. Honorary membership
  1. Honorary members may be appointed by the committee of natural or legal persons who make a significant contribution to the values whose development constitutes the mission and goals of the association;

2. To appoint an honorary member, the association must request his prior consent;
3. Honorary members have the right to participate in the normal activities of the association, including committee meetings, they can submit their proposals and comments on the activities of the association;
4. Honorary members are exempt from paying membership fees.
5. Honorary membership expires:
  1. By submitting a written request of a member for deprivation of honorary membership of the committee;
  2. Exclusion of an honorary member by the committee;
  3. Death of an honorary member of the association (membership rights and obligations are not inherited or otherwise transferred to the heirs);
  4. Dissolution of the association.
6. Membership expires:
  1. Serious breach of the obligation arising from membership;
  2. By delivery of a written notice of withdrawal to the member;
  3. Exclusion decision;
  4. Failure to pay membership fees even within a reasonable additional period;
  5. Death of an honorary member of the association (membership rights and obligations are not inherited or otherwise transferred to the heirs);
  6. Dissolution of the association.
7. The member has the right
  1. Participate in the activities of the association and its bodies and be informed about these activities;
  2. Submit proposals, suggestions and comments on the activities of the association;
  3. Participate in setting goals and forms of association activities.
8. The member has a duty
  1. Adhere to these statutes and act in accordance with the goals of the association; (fulfill the goals of the association by its activities);
  2. Pay membership fees.
9. The amount of membership fees is always determined by the association committee for the relevant calendar year.

#### **art. V**

##### **Association bodies**

Association bodies are:

1. Statutory body – chairman;
2. The highest authority – association committee.

#### **art. VI**

##### **Statutory body – chairman**

1. The statutory body of the association is the chairman;
2. The term of office of the Chairperson shall be ten years.

#### **čl. VII**

##### **Association committee**

1. The committee is the highest body of the association; it shall meet at least once a year;
2. The Committee shall consist of three members;
3. The members of the committee are elected by the members of the association. In the event of termination of membership in the association or resignation as a member of the committee, the committee is supplemented by co-optation of the remaining members of the committee;

4. A quorum shall exist at a Committee meeting if a majority of the members of the Committee are present and, if it does not meet in the required number, an alternate meeting of the Committee shall be convened no later than six days. A new meeting of the Committee shall have a quorum regardless of the number of members present. The committee shall take its decisions by a vote; the approval of an absolute majority of the members present is required for the adoption of a decision, unless these statutes provide otherwise. Each member has 1 vote;
5. The Committee may be convened at the request of 1/3 of the members of the Association, within a period of one month, unless a later period is specified in the request.;
6. The term of office of the Committee shall be five years;
7. In the event that a resolution of the Committee opposes or contradicts these Statutes, it shall be treated as if it had not been adopted..
8. Committee
  1. Elects the president of the association;
  2. He Approves the statutes of the association and their amendments, decides on the dissolution of the association, for the adoption of these decisions requires the consent of 2/3 of the members of the committee;
  3. Approves the budget, the activity report, the management report for the previous period and the audit report;
  4. Specifies the activity for the next period;
  5. It determines the amount of membership fees.

#### **art. VIII**

##### **Management principles**

1. **The association is a non-profit organization.** Any income will consist of donations, subsidies, grants and income from the activities of the association and the property of the association, and will be used for the activities of the association;
2. The expenses of the association are focused on the realization of the goals of the association in accordance with its main activities according to these statutes and the budget of the association.

#### **art. IX**

##### **Circumstances of the dissolution of the association**

1. In the event of the dissolution of the association by a decision of the membership meeting, a property settlement will be made.
